There is a one (1) year minimum commitment to membership. Memberships canceled prior to one year will be liable for the remaining term dues. **Monthly Auto-draft payments are required for all YPM either by credit card or checking account.**

**Young Resident Member:**

Age 30 to 39, residing or doing business within 25 miles of the City Hall of Chattanooga. Monthly dues are \$120. Food and Beverage Minimum per quarter. \$100 annual holiday fund contribution (staff holiday bonus). **\$500 Initiation Fee** due at the time of application submission. There is a one (1) year minimum commitment to membership. Memberships canceled prior to one year will be liable for the remaining term dues

**Resident Membership:**

Age 40 or older, residing or doing business within 25 miles of the City Hall of Chattanooga. Monthly dues are \$220. Food and Beverage Minimum per quarter. \$100 annual holiday fund contribution (staff holiday bonus). **\$1000 Initiation Fee** due at the time of application submission. There is a one (1) year minimum commitment to membership. Memberships canceled prior to one year will be liable for the remaining term dues

**Non-Resident Membership:**

Those who do not reside or do not do business within twenty five (25) miles of the City Hall of Chattanooga, Tennessee or within such other distance as may be considered by the Board to constitute the equivalent of Resident members. **Quarterly dues are \$220.** No food & beverage minimum. \$100 annual holiday fund contribution (staff holiday bonus). **\$500 Initiation Fee** due at the time of application submission. There is a one (1) year minimum commitment to membership. Memberships canceled prior to one year will be liable for the remaining term dues

**Legacy Membership:**

Those whose parent, stepparent, grandparent, step-grandparent, great-grandparent or step-great-grandparent was or is a member of the Club. Monthly dues are dependent on category. Food and Beverage Minimum per quarter. \$100 annual holiday fund contribution (staff holiday bonus). **\$500 Initiation Fee** due at the time of application submission. There is a one (1) year minimum commitment to membership. Memberships canceled prior to one year will be liable for the remaining term dues
